District Goals

The Muscogee County School District will implement evidence-based Tier 1 instruction, a Multi-Tiered System of Support (MTSS), leadership development, and a culture of kindness.

School's Smart Goals

Smart Goal #1 By May 2020, 100% of all teachers will implement quality Tier I differentiation in all subject areas with 90% effectiveness to guide instruction while using writing strategies thereby increasing students learning as measured by focus walks and student assessment data.

Smart Goal #2 By May 2020, 100% of classroom teachers will implement module 1(rituals and routines) and module 2 (acknowledgement systems) of PBIS in the Classroom with 80% effective implementation as measured by SWIS data and classroom calibration walks.

WHAT IS TITLE I?

Georgetown Elementary is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is a federal grant that was designed to ensure that all children receive a high quality education and reach grade level proficiency. Title I programs must be based on effective means of improving student achievement and include strategies to support parent and family engagement.

School Measures to Provide Required Assistance
