Ref: Change in Format of ACH Payment Notification

The MCSD Division of Financial Services and the Division of Information Services ERP team are excited to announce a new feature that will soon be available to MCSD vendors.

Currently the notification/advice of funds deposited by electronic fund transfer (EFT) through ACH to vendor bank accounts of record for MCSD vendor payments is sent to MCSD vendors through the US Mail. <u>Starting</u> July 2012, this notification will be emailed to vendors.

- The email notification will be sent to the vendor's email address submitted on the EFT request form.
- Please do not reply to the email.
- Any concerns or questions about the emailed payment notification should be directed to the Accounts Payable Department address shown on the notification.
- The EFT notification/advice will be sent by US Mail through July 31, 2012.
- After July 31, 2012 this email notification of funds deposited to the vendor bank account of record will be the only notification sent out.
